

Royal Government of Cambodia

Covid-19 Response Updates

The <u>Royal Government of Cambodia</u> has issued a sub-decree on the edition of article 8 of sub-decree 129 registered on the 15th of September 2015 on health measures to stop and respond to the global spread of the disease at the border entrances, dated February 18, 2021.

The <u>Ministry of Culture and Fine Arts</u> has issued a notification of the restriction to apply the Standard of Principles (SOP) in preventing the transmission of COVID-19 at various cinemas, art galleries and museums in the Royal Government of Cambodia, dated February 20, 2021.

The <u>Ministry of Labour and Vocational Training</u> has issued a notification on COVID-19 prevention measures at various factories and enterprises during the Community Event 20 February, dated February 20, 2021.

The <u>Ministry of Education</u>, <u>Youth and Sports</u> has issued a notification of measures for education officials at national agencies to prevent and stop the spread of COVID-19, dated February 20, 2021.

The <u>Ministry of Education</u>, <u>Youth and Sport</u> has issued a notification of the restriction of safety health education measures at public and private educational institutions in Phnom Penh, dated February 20, 2021.

The <u>Ministry of Tourism</u> has informed the municipality and provincial governors to continue strengthening the instruction principles application of the Royal Government of Cambodia and tourism safety measures at the local tourism services in the cities and provinces, dated February 21, 2021.

The <u>Ministry of Tourism</u> has informed the governors of the municipality and province about the continuation of strengthening a measure to temporarily close KTV, Entertainment Clubs (Karaoke, Bars, Discotheque and Beer Garden) with daily strict monitoring, dated February 21, 2021.

The <u>Ministry of Education</u>, <u>Youth and Sports</u> has issued a notification with regard to the temporary deferment of Hun Sen Phnom Penh Thmey High School and the AIS International School Lucky Star Branch, dated February 21, 2021.

The <u>National Committee for National and International Festivals</u> has issued an instruction plan on the arrangement of Khmer New Year 2021, dated February 22, 2021.

The <u>Ministry of Labour and Vocational Training</u> has issued a notification of the temporary deferment of education for two weeks at Technical and Vocational Training and Education Institutions in Phnom Penh and Kandal province, dated February 22, 2021.

The <u>Ministry of Education</u>, <u>Youth and Sports</u> has issued a notification of the restriction of the application of educational health and safety measures at public and private education institutes across the country, dated February 22, 2021.









The Ministry of Education, Youth and Sports has issued a notification of the deferment of public and private educational institutions temporarily for two weeks in Phnom Penh and Kandal province, dated February 22, 2021.

The Phnom Penh Municipality has issued the instruction on the restriction of a social distancing measure and individual distancing in Phnom Penh base to prevent and fight against COVID-19 from "Community Event 20" February", dated February 22, 2021.

The Ministry of Culture and Fine Arts has issued a notification of a temporary two-week close of cinemas, art galleries and museums in Phnom Penh and Kandal province, dated 23 February 2021.

The Ministry of Labour and Vocational Training has issued a notification of the deferment of direct physical check-up at the Department of Occupational Health and Safety due to the infection of COVID-19 from the "Community Event 20 February", dated 23 February 2021.

The Phnom Penh Municipal Court has issued a notification of the postponement of hearing schedule due to the COVID-19 situation from "Community Event 20 February", dated 23 February 2021.

The Ministry of Foreign Affairs and International Cooperation has informed foreigners who have stayed and worked in Cambodia that they can have COVID-19 vaccine injection for free in compliance with COVID-19 vaccine injection plan of Cambodia, dated 24 February 2021.

The Ministry of Education, Youth and Sports has informed Phnom Penh, Kandal, and Sihanouk province governors to temporarily postpone gymnasiums and suspend playing sports or all types of exercises in a collective form, dated 24 February 2021.

The Ministry of Tourism has issued a notification of the temporary deferment at Tourism Professional Training Department, Tourism Professional Training Schools, and Evaluation Centers under the Ministry of Tourism in Phnom Penh and Kandal provinces for two weeks, dated 24 February 2021.
