



**"DELEGATION OF INSPECTION OF COVID-19 VACCINATION CERTIFICATES ON
INTERNATIONAL TRAVELERS TO IMMIGRATION POLICE OFFICERS AT
INTERNATIONAL BORDERS: LAND, WATER, AIR, BILATERAL AND REGIONAL
GATEWAYS"**

According to the letter No. 124 dated 18th April 2022 of the Ministry of Health of the Kingdom of Cambodia, the Ministry of Tourism of the Kingdom of Cambodia is honored and pleased to inform the tourism associations, private sector, international travelers and the public that the inspection of Covid-19 vaccination certificates had previously been carried out by the health officials except at Phnom Penh International Airport conducted by the immigration police officers.

Hence, in order to facilitate foreign travelers and to reduce the burden of the government's budget, the **Inter-Ministerial Committee Combating Covid-19** would like to delegate the inspection of Covid-19 vaccination certificates on international travelers to **immigration police officers at international borders such as land, water, air, bilateral and regional gateways**.

根据柬埔寨王国卫生部 2022 年 4 月 18 日第 124 号通告，柬埔寨王国旅游部很荣幸地通知旅游协会、私营部门、国际旅客和公众：此前，除在金边国际机场是由出入境管理人员检查新冠疫苗接种证书外，均由防疫管理人员检查新冠疫苗接种证书。因此，为了方便国际游客并减少政府的预算负担，防治新冠病毒部际委员会决定，将国际旅客新冠疫苗接种证书的检查工作委托给陆路、水路、空运、双边和区域门户等入境管理人员。
