Policy Updates from Ministries

The <u>Ministry of Labour and Vocational Training</u> has issued a guideline on the suspension of employment contracts for factory workers in the textile, garment, footwear and travel products and bags sectors affected by the global economic crisis, dated March 15, 2023.

The <u>Royal Government of Cambodia</u> has issued a sub-decree on the conditions and procedures for business integration dated March 6, 2023.

The <u>Office of the Council of Ministers</u> released the Royal Government's decision not to tax the income of public and private educational institutions throughout the country from 2024 to 2028, dated February 27, 2023.



The <u>Supreme National Economic Council</u> released a Development Strategy on Cambodia's Garment, Footwear, and Bag Production Sector 2022-2027, dated February 23, 2022.

The <u>Ministry of Industry, Science, Technology & Innovation</u> released National Research Agenda 2025, dated January 18, 2023.

The <u>Ministry of Civil Service</u> issued a Letter to Deputy Prime Ministers, Senior Ministers, Ministers, and Head of Government Institutions on the Principles for the Use of Framework for Civil Servants, Contract Officers, and Other Types of Teachers for 2023, dated January 3, 2023
